• Part-time** Non-resident Tuition, (undergraduate & Post baccalaureate. Part-time non-resident tuition rates are assessed to students enrolled in fewer than 7 credit)	\$161.50 per credit
• WUE Tuition, NSC (undergraduate & Post baccalaureate)	\$73.38 per credit
• Distance Tuition Rate (Assessed only to non-resident students who are residing outside of Nevada during the semester in which enrollment in the distance education course(s) occurs.)	\$73.50 per credit

Fee changes put in place less than 30 days before commencement of classes will not be subject to late fee penalties.
